Terms of Use for cnwsc.net | Social Games

Effective as of 26 December 2025

ATTENTION: OUR PLATFORM PROVIDES SOCIAL ENTERTAINMENT AND IS NOT AN ONLINE CASINO, SPORTSBOOK, OR ANY FORM OF REAL-MONEY GAMBLING. No deposit or purchase is necessary to participate in the games. You can play for free.

Purchasing Gold Coins is strictly voluntary and constitutes a payment for enhanced entertainment and immediate access to gameplay features within the Services. It is not a wager.

All purchases of Gold Coins are final and non-refundable, except as otherwise required by applicable law.

3.3. No-Purchase Participation. No purchase is ever necessary to play. Registered users can obtain Gold Coins through various free methods, such as daily login bonuses, promotional events, and other non-purchase mechanisms provided by the platform.
